8. Outside Choreographers can be used for solos at the approval of the Company Director. In addition soloist must have one solo choreographed by a Staff member of UDC. Solo fees for outside choreographers are at their specific choreography rate plus rental space fee of \$25 per hour. All choreography must be done in studio. Company Director has final say over all choreography.
9. Mini's Company competes in Tap, Jazz, and 1 Line (if selected- Line cost is not included in monthly tuition rate and will be additional cost.
10. Evolution Company competes in Jazz and Lyrical.
11. Dancers 12 years of age or younger as of Jan. 1, 2021 will compete in Jazz, Tap, Hip Hop and 1 Line. All other genres will be chosen by the Company Director.
12. Dancers 13 years of age and older as of Jan. 1, 2021 will be placed in 4 dances chosen by Company Director which are required. All dancers 13 and over will compete in minimum of 4 dances.
13. Each dancer may be asked to participate in an outside Choreographers Piece. The cost of that Piece will range from \$175-250 per dancer. Monies are due the day Choreography starts if hand selected by choreographer, or due date given. If you pass no other solo, duo/trios, or small groups will be available.
14. Select dancers will participate in a production number and each year we have Mrs. Jill team together with Ms. Shannon to do choreography. Cost: \$40 per dancer due October 15th, 2020.
